## **IV.** New Business

- 4.1 Look back at allocations from May 2013 recommendations VP Kim
- Chair Mead provided a brief background on the FY 2013-2014 PRBC recommendations approved by the President in May 2014
- VP Kim presented an overview of 2013 recommendations from a power point entitled 'Reinvesting in Instructional and Support Infrastructure' presentation forwarded by Sheretha Benjamin on April 3rd
  - Allocation of \$11 million to specific areas including Building and Grounds,
     Maintenance, Chargebacks for State Funded Projects, University Police Staffing
     (Dispatcher and Officer)
  - o Facilities \$3 million set aside to hire 65 positions (Custodial, Trades, Support, Landscaper) level of campus grounds cleanliness has improved

- Chargebacks Efforts to clarify re-charges and minimize amounts charged to departments
- o Police Hire two Officers and one Dispatcher to help in providing 24 hour Coverage on campus
- Hidalgo offered a brief update on the IT Data Center Upgrades and Instructional Technology
  - \$500k allocated and IT Division contribution of \$150k to fund the upgrade of projectors in classroom, UPS (un-interrupted power supply) takes over during power outages
- VP Eanes spoke about the Space Development for Cultural Centers
  - o Received feedback from campus on how to better facilitate staffing, faculty, and student programs, and plan ethnic celebrations to address equity issues
- VP Saks discussed the Advancement Space Improvement & Compliance o \$40k funded to upgrade the 8<sup>th</sup> floor conference room
- Meyer added to the conversation in an update on Replacing Performing Art Stage Rigging to address safety
- VP Kim concluded the presentation with a review of before-after photos of various projects: Classroom Refurbishment, Instructional Facilities Improvements, and Irvine Campus – additional space
  - o CS-309 Computer Lab, EC-62/66 Classroom, MH-47, MH-6<sup>th</sup> Floor Lab, KHS Academic Success Center, PL-Honors & Scholars
- Provost Cruz addressed Chair Mead's question regarding the \$700k allocation for Student Advisory Services to build infrastructure and provide analytic tools to help Graduation and Retention Specialists. EAB changed platform, current pilot in College of Health and Human Development (HHD) with a full rollout expected in Spring 2015
- Campaign to focus on achievement gaps as goals on graduation rate were met
- Retention Specialist recruitment update Currently in final stages but multiple colleges vying for the position
- Bonney commented on challenges with classroom projectors and lighting. Kopecky maintains a list of classroom refurbishment/deferred maintenance items with feedback from Associate Deans/College Representatives and works with appropriate parties (Facilities, IT) to prioritize and address.
- VP Kim mentioned Governor Brown's Executive Order (May 1, 2015) on addressing California's drought requiring a statewide reduction of 25% in water usage
- 4.2 Joint presentation on initiatives for 2015-16 Division Heads
- Division Heads will share a joint presentation based on various budget scenarios
- Provost Cruz and VP Kim will talk about the current year allocation process for next year at the April 17<sup>th</sup> meeting

- 4.3 UPS 100.900 Procedures to Establishing Schools at California State University, Fullerton subcommittee
- Bonney presented a revised UPS 100.900 (Procedures for Establishing Schools at California State University, Fullerton) document and asked for feedback:
  - o Suggestion to amend verbiage to page 3: "As part of the recommendations, the ad hoc committee should include the following elements:"
  - o Move the first item on the list (#1) to the last (#4) and re-number the statements
- MSP Dabirian, Meyer Approve the proposed amendment to UPS 100.900 and move the document forward to Academic Senate
