- 4.1 Department of Communication Sciences and Disorders
- Guest Fink, Acting Dean of the College of Communications provided background on the Department of Communication Sciences and Disorders proposal and address questions from members. Guest Faire, Budget Officer was also present at the meeting.
 - o Academic Senate and University Curriculum Committee approved the Department of Communication Sciences and Disorders proposal.
 - It splits Human Communications into two separate departments with the existing degree-programs: Human Communications and Communication Sciences and Disorders.
 - o The communicative disorders program (i.e., speech pathology) has offered Bachelor and Master degrees while the degrees in Human Communications focus on communication studies.
 - o There is a demand for a separate degree program which would maintain separate marketing and branding, and supports accreditation. Baseline budget would be split from Human Communications (70/30) and utilize current staffing. Future growth may require a need for additional office space.
